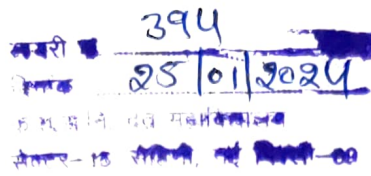





Report –Student Grievance Committee.

In reference to UO note no. 115-A-P.F./Students/826/2020/Univ.DC dated 13.05.2023 regarding re-investigation of case of Mr. Sarvpriy, Enroll No. 82650759120; Student Grievance Committee met on 31.05.2023 to reinvestigate the case at 2:00 PM in Oral Pathology lab. In reply the points raised in UO note regarding the report submitted by Student Grievance Committee on 17.04.2023, it is informed that:

1. Behavioural aspect of the subject teacher was taken up by the committee because the grievance of father of Mr. Sarvpriy forwarded to the committee is regarding the vindictive attitude of subject teacher towards the student.
2. Matter regarding the marks was also taken care of regarding which committee mentioned that as per the statement of the internal examiner/subject teacher marks were already forwarded to the university and there is no record available in the department. Recommendations were given accordingly.
3. As per norms student should be the part of committee, but there was a conflict of interest in this case, as Mr. Sarvpriy is the Student representative in Student Grievance Committee and he himself was the complainant.

However, the case was reinvestigated on 31.05.2023 and following committee members as approved on file were present:

Proceedings:


- Committee members asked Mr. Sarvpriy about his actual grievance points to which he said that he does not have any grievance now. He informed committee members that his father Mr. Parveen Singh has also given an application in the office that he will withdraw the court case he has filed. Process of withdrawal is under process as informed by Mr. Sarvpriy.
- Mr. Sarvpriy has one concern that is there any way that his subject carryover can be removed and he will be allowed to sit with his regular batch.


To which committee made it clear to him that these are the norms laid down by the University and DCI hence cannot be modified/changed.



submitted by the student with his complaint were handed over to him by Dr. Bhawana Tiwari herself.


