OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Buyer Added Bid Specific ATC

# **Eligibility Conditions to bidders:-**

- **1**. The Bidders should not have been inducted for any criminal, fraudulent or corrupt ion activity and not have been blacklisted by any Central/State Govt/Semi-Govt/PSU/Autonomous Body/Reputed Corporate Sector-Firms. In this regard Declaration must be submitted.
- **2.**The **bidders** should be a company/firm/proprietary/partnership engaged in supply of manpower for at least 03 years.
- 3. The bidder must have minimum annual turnover of Rs. 2. 85 crore Only/-

(Rupees Two Crore Eighty Five Lakh only) or more during the last three financial years each i.e. 2020-21, 2 021-2022 & 2022-2023.

- **4.**Proof of relevant documents should be submitted with supporting evidence such as, ESIC Sub code, land phone, registration from concerned local self-government etc.
- **5.**The Prospective bidders are hereby encouraged to participate in the pre-bid meeting to eliminate any a mbiguity or doubt regarding the bid documents. Nonparticipation in the pre-bid meeting will be deemed as an acceptance that the bidder has no doubts or ambiguities about the terms and conditions of the bid and has fully understood the essence of bid documents. Consequently, after the award of the contract, no furth er questions, clarifications, or requests for modifications will be entertained, and the bidder will be obligate d to comply with all terms and conditions of the bid and in any circumstances the discretion of Department will be final.

#### 5.Turnover

Bidder Turn over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Charter ed Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid.
